# Recreation Commission By-Laws Mission Statement

January 26, 2004

The WRCC shall provide suitable recreational and leisure time activities as desired by the Town of Wheatland residents. The WRCC shall be responsible for the administration and execution of recreation and cultural programs for the Town of Wheatland Residents.

The WRCC shall furnish and operate playgrounds, recreation centers and other recreation areas and facilities owned or controlled by the Town of Wheatland and/or Village of Scottsville. These activities may be conducted on properties under the Commission's control, on public property with the consent of the authorities thereof, and on private property with the consent of the owners thereof. The WRCC shall develop and execute a plan for future recreation/cultural programs and facilities.

This plan shall be aligned with the Town of Wheatland Master plan.

Development, review and approval of strategic objectives that are aligned with the strategic framework defined within this document, the **Town of Wheatland Master Plan** and relevant Town strategic objectives and operating plans.

#### Recreation Commission By-Laws Mission Statement

Revision 3.0 June 4, 2015

The Commission shall work in close cooperation with the Town of Wheatland Recreation Department, providing strategic direction and operational guidance that balance the enhanced quality of life needs and desires of the community with the strategic objectives and annual operating plans of the Wheatland Town Government, including:

- Facilitating the successful planning and execution of Town sponsored and cooperative leisure time events, activities and services that deliver pleasurable, fun and enriching experiences for participants while at the same time nurturing participants' health and well-being.
- Providing guidance for the ongoing development of a portfolio of Town sponsored enhanced quality of life programs that address the most comprehensive possible demographics of the Wheatland community.
  - Actively helping market the vision and values of the Town that promote the Wheatland community as an abundantly desirable place to live, work and visit, while emphasizing the values and benefits of the Town's local amenities (i.e., community infrastructure, parks, natural resources).

Facilitating broad community engagement through the application of appropriate and effective communications methods and techniques to connect across the breadth of the Town of Wheatland stakeholder base, comprising: residents, potential residents, businesses, employees, suppliers, visitors, and other Municipal Government and organization representatives.

Providing leadership in defining, promoting and realizing the vision for Town of Wheatland sponsored enhanced quality of life experiences, including the evolution of local amenities and related Town provided infrastructure.

# Recreation Related Excerpts from Town of Wheatland; Village of Scottsville Comprehensive Plan 2004 - 2024

December 2, 2004 (November 9 2004)

- 1. Create an integrated system of parks and recreational facilities throughout the community, including undeveloped open space as one component, with linkages as feasible between state, county, town and village facilities such as pathways, stream corridors, trails and utility rights-of-way. Recognize recreation as a community need, and an asset worth developing; Promote recreation as a way of life in the community, including a method of promoting commerce, and plan for community funded recreation improvements and facilities such as wide highway shoulders for bicycling, multi-purpose trails for hiking, pedestrian links between parks and recreation areas, and improved access to fishing spots.
  - ..... policy of maintaining adequate recreation facilities once constructed, and budget .... annually for upkeep.
  - Utilize the development review process to make developers aware of local recreation resources and require that their proposals include access to existing recreation areas where feasible and offer new recreation opportunities......
  - Maintain an awareness of potential land sales with imminent recreation potential and consider land acquisition when necessary to gain control over key recreational resources, especially water access ......
  - Promote private investment in recreation facilities so as to obtain services for the community while deferring the municipal expenses associated with construction and maintenance of public recreation facilities.
- 2. ..... studies should include a survey of available athletic fields and playground equipment using recognized standards provided by groups such as the New York State Recreation and Parks Society (NYSRPS.)
- Consider construction and/or rehabilitation of facilities that make use of the resources spread throughout the town. Such
  facilities include parks, bicycle routes and/or trails that link our many resources, athletic fields, recreation
  facilities, and any other civic facilities that interest the general public.
- 4. Establish a common marketing theme that all merchants can build upon, such as "tourism, art, historic exploration, great place to live and work, and/or recreation," ......
- 5. For Canawaugus Park, it is recommended that special consideration be given to providing a physical link between the Greenway (regional park patrons) and the village business district (potential provider of services needed by regional park patrons,) providing special trailhead attractions such as creek access points, comfort facilities, additional trail spur connection opportunities, historic interpretive facilities or other features specifically designed to draw the recreational users to the immediate village downtown area as a trip origin or destination.



#### 2. SPRING PROGRAM UPDATE

Easter Party ~ 390 participants (children & adults) at Johnson Park in Scottsville; 40 participants in the follow-on Greenway walk with a State Park Guide; American Legion cooked 290 hot dogs; 2000 plastic eggs were used for the Easter Egg Hunt; 600 more eggs used for the Greenway walk; There was a magician at Johnson Park, crafts and games. Wheatland Recreation was the primary coordinator for this event and partnered with the Scottsville American Legion and Genesee Valley Greenway State Park.

#### 3. SUMMER FUN DAY CAMP; BEFORE/AFTER CARE PROGRAMS PROPOSALS

- Summer Fun Day Camp and Before/After Care programs schedules were updated based on changes to the Wheatland-Chili School calendar, programs will run as in the past: a 6-week program minus 4<sup>th</sup> of July day (29 days total).
- The targeted number of participants remains at 125 from the 2019 program plan baseline with the maximum capped at 130 (driven by building capacity).
- Proposed program fees were previously updated for 2019 to reflect additional labor costs for NYS and Monroe County required training in conjunction with new credit card fees, additional fee updates were incorporated to cover the two added days from the school schedule change. Fees for these programs are expected to be reviewed and approved by the Wheatland Town Board.

Program cost ratios are within the targeted ranges for these programs as
established in the annual baseline plan (Summer Camp program effectively
break a financial even with included department overheads; Before / After Care
programs delivering small net profit with same overheads). These programs
continue to reflect significant value to the community as compared to other
types of youth camp programs in the region.

<u>Resolution</u> – Cheryl Marginean made a motion to approve the proposed 2019 Summer Camp and Before / After Car programs with fees as amended during the meeting, Jenny Smith seconded the motion. The motion was approved by unanimous vote of the Commission.

#### E. Old Business

#### 1. Q1 FINANCIAL REVIEW

Mark Turner presented the financial results from the Winter Period (2019 first quarter) for Commission review. Highlights include:

- 552 participants, record for Winter Period.
- Q1 programs aggregate cost ratio a bit higher than planned (less net profit than planned) primarily due to a few programs with lower participation than planned (continued to run programs with objective of maintaining continuity, will focus on participation growth for these programs in coming periods).
- Overall forecast for 2019 financial performance continues to be in line with baseline plans.

#### F. New Business

#### 1. COMMUNITY HALL OF FAME - "VOLUNTEERS OF DISTINCTION"

Mark Turner presented a preliminary proposal for the addition of a new community recognition of citizens as part of the existing Wheatland Community Hall of Fame, called "Volunteers of Distinction". Highlights include:

- Volunteers are defined as people who freely give time, effort and talent to a community need, cause or organization without compensation (i.e., getting paid).
- "Volunteers of Distinction" is defined as citizens who have made positive contributions through demonstrated excellence as volunteers in support of the Town of Wheatland community (not just associated with the Town Government.

- There will be a formal nomination, evaluation, selection and recognition process similar to the Community Hall of Fame processes, albeit with a different set of criteria and a different level of recognition.
- Volunteers of Distinction will be operated on an annual cadence in conjunction with the Community Hall of Fame cadence.
- There are no costs anticipated to the Town in support of this activity.

Commission consensus for Mark Turner to present the proposal as a recommendation to the Wheatland Town Board.

#### 2. RURAL ECONOMIC DEVELOPMENT INNOVATION (REDI) INITIATIVE

- Mark Turner shared preliminary information regarding a recently submitted REDI application to the United States Department of Agriculture (USDA) supported by Wheatland in conjunction with other communities in the Genesee Valley Region (including across five counties in Western New York). The fundamental premise of this strategic initiative would be to facilitate sustainable regional economic growth while maintaining small town and natural environments through a network of communities and opportunities linked to outdoor recreation and tourism.
- The purpose of sharing this information with the Recreation Commission was
  to provide context for potential future considerations regarding outdoor
  recreation in our community (i.e., assessing needs, identifying opportunities),
  which is aligned with the defined objectives of the Recreation Commission.
  Clearly this would require significant collaboration between multiple
  organizations within the Town Government and across the Wheatland
  community at large. There are no actions planned or required by the
  Recreation Commission at this time.

#### 3. TOWN BOARD REPORT

 Mark Turner reviewed the Town Board Report in the form of a quad chart with the Commission; updates were incorporated based on the discussion, including depicting Town investment levels on the financial trends graph as negative numbers and showing YTD participant numbers on the program participation graph in conjunction with the remaining forecast (report is attached at the end of these meeting minutes).

#### G. Other Business

#### 1. MARKETING AND ADVERTISING

Lisa Wasson suggested developing marketing material that could be used across multiple media in promoting the many very successful events offered by Wheatland Recreation (i.e., Easter Party). The media would ideally include newspapers with broad distribution such as the Rochester Democrat & Chronicle. Mark Turner mentioned that this concept is aligned with the objectives and strategies defined in the Town of Wheatland strategic plan. A branding manifesto is under development and review which is intended to be used as the basis for this type of marketing collateral.

The consensus of the Commission is that this is a great idea and will be considered for implementation in the near future. In addition, an article is planned for the upcoming Summer Town Newsletter describing the history, evolution and current offerings of the Summer Fun Day Camp program.

#### 2. <u>NEXT REGULAR MEETING</u>
