Presentation by Eric Weis of CPL Architecture, Engineering & Planning Firm

Mr. Weis explained a process that CPL uses to garner public input so communities can decide whether to pursue public water. He said that they have been doing this for about 25 years now and perfected the process over time. They have an online and paper survey that is available for the residents in the community. The results of the survey indicate whether there is interest, no interest or maybe interested. The results are then put into a map format. After the map has been created, public input meetings are usually held.

Supervisor Kirch said that the idea is to have the link to the survey in the next Town newsletter. He said that CPL does not charge for the survey or analysis and there is no commitment to CPL if they do conduct the survey.

Josh Hickel presented an Advisory Petition to the Board for the investigation into forming a water district on South Road.

Peter Humphrey said that he also lives on South Road and has 3 wells on his property and only one has useable water after being treated. He said that they bring in bottled water because the well water is not good.

Barb Chapman, Historian said that for about a year Nathan Ruekberg has been helping her in the Historian's Office. Nathan is a descendant of the Harmon family, and his ancestors go back to the beginning of the Town, so he is very interested in Wheatland history. He has cataloged her books in the office and is now scanning and digitizing the photographs in her collection. She said that she is currently working on a book about Wheatland and the Revolutionary War since it is the 250th anniversary of the Revolution.
